Our Courses

B.A.LLB.

The College offers B.A.LLB. integrated course as a part of its undergraduate program. The integrated degree is a modern approach to legal education. In this course, a student covers two courses under one academic program, one in arts and the other in law. In this course, the initial 2 years of study comprise of subjects related to BA and the subsequent 3 years deal with subjects related to Law.

Faculty members and staff at SMKCL are well experienced and committed towards their work. Our Campus environment has been designed for holistic development of students. The College has created a balanced course structure with a fine combination of curricular schedule and co-curricular activities. The College aims towards shaping the students into skilled and hard working professionals.

Course Structure

B.A.LLB. is a 5-year integrated course in the field of law. Each academic year is divided in two semesters. The odd semesters span from July to December and the even semesters span from January to June. There are total 10 semesters in 5-Years and 5 subjects in each semester.

Eligibility Criteria:

Candidate must have passed Senior School Certificate Examination (10+2 System) or equivalent examination with at least

- 45% marks in aggregate for General Category
- 42% marks in aggregate for OBC Category
- 40% marks in aggregate for SC/ST Category



LLB.

The course curriculum of LLB. is purely based on Law subjects. The course covers both theoretical and practical aspects of law, and it is interlaced with assignments. Mostly, professionals who aspire to work in the judiciary, litigation, civil services or academic department pursue this course.

Course Structure

LLB. is a 3-year course. Each academic year is divided in two semesters. The odd semesters span from July to December and the even semesters span from January to June. There are total 6 semesters in 3 years and 5 subjects in each semester.

Eligibility Criteria:

Candidate must have passed Graduation/Post Graduation Degree in any discipline from a recognized University, with at least

- 45% marks in aggregate for General Category
- 42% marks in aggregate for OBC Category
- 40% marks in aggregate for SC/ST category

NOTE:

1. Candidates appearing/appeared for the annual examination in March/April and those appearing in semester examinations in May-June are also eligible to apply.
2. No Age Limit.
3. All the above mentioned rules & regulation are subject to guidelines of C.C.S. University, Meerut(CCSU) and Bar Council of India (BCI).

Documents required at the time of admission:

- 10th Marksheet and Certificate
- 12th Marksheet and Certificate
- Graduation/Post Graduation Marksheets and Degree (only for LLB. aspirants)
- Transfer/Migration Certificate
- Aadhar Card
- Category Certificate SC/ST/OBC/EWS (if applicable)
- Six passport size recent photographs

2 Sets of photocopy of all the above said documents.

All original documents would be required for verification.

Career opportunities after B.A.LL.B. and LLB.

A lawyer is a professional who is qualified to offer advice about the law or represent someone in legal matters. A lawyer can also be called an attorney, a solicitor, a counsellor or a barrister.

After completing B.A.LL.B./LLB. students have opportunities in Judicial Services, Government Agencies or Private Law Firms. They can also serve as Criminal Lawyers, Corporate Lawyers, Legal Journalists, Legal Analysts, Civil Lawyers, and Legal Advisor, etc.

Fee Structure :

- The Tuition fee is Rs. 35,000/- per year for LLB./B.A.LL.B. Course.
- University examination fee would be paid by candidate on actual basis, at the time of filling of their examination form.

It is to be noted that, fee defaulter has to pay Rs. 500/- per month as penalty in addition to the balance tuition fee.
